1. Who we are

In this privacy statement references to "we", "us" and "our" are International Confederation of Futebol de Salão Global Limited or "ICFDS Global Limited". References to "our Website" or "the Website" are to www.icfds.com. This privacy statement will tell you how you can verify the accuracy of your personal information submitted to ICFDS Global Limited and how you can request that we delete or update your personal information. 2. What information we collect and how
